PLEDGE OF ALLEGIANCE

Mayor Woerther led the Pledge of Allegiance.

APPROVAL OF MINUTES

The minutes of the January 11, 2016, City Council meeting were submitted for approval. A motion was made by Council Member Marshall, seconded by Council Member Manton, to approve the minutes. A mistake was noted regarding the use of the incorrect pronoun, in reference to one of the public speakers. This item was noted, and City Clerk Weiss added it would be corrected. A voice vote was taken with an affirmative result and the motion was declared passed on the minutes, as amended (Council Member Bowlin abstained).

MAYOR APPOINTMENTS/ANNOUNCEMENTS

Mayor Woerther thanked the Department of Planning and Parks for another successful recreation event on Saturday, January 23, 2016. He noted the annual Frozen Feet Half Marathon Trail Run was well-attended and enjoyed by all, thanks to the efforts of City Staff and volunteers.

Mayor Woerther requested the support from the City Council in appointing the following individuals to the Committee to review whether to extend the Pond-Grover Loop Road into the Villages at Bright Leaf Development and to State Route 100 at Taylor Road: Ed Marshall (Council Member Ward 2); Jim Baugus (Council Member Ward 3); Joe Garritano (Council Member Ward 8); Paul Pohlers (Sandalwood Creek Subdivision); Christy Pitney (Hickory Manor Subdivision); and Debbie Sinden (Evergreen Subdivision). Mayor Woerther added he chose the aforementioned individuals because he believed they could be objective and base their recommendation(s) on information gathered during the review process.

A motion was made by Council Member Manton, seconded by Council Member Garritano, to confirm the appointment of members to the Pond-Grover Loop Road Committee, as recommended by Mayor Woerther.

Discussion was held among City Council Members regarding the following items: the belief the committee will be beneficial in determining an outcome for the Pond-Grover Loop Road and will listen to all interested parties involved; concern with the appointment of Debbie Sinden, since she is running for Council Member in Ward 5; the belief one of the current Council Members of Ward 5, Debra Smith McCutchen, should be appointed to serve on this committee and had requested to be appointed to it; and the belief there is a discrepancy in appointing one of the candidates running for Council Member in Ward 5.

PUBLIC PARTICIPATION

Tammy Shea, 18132 Sunny Top Court, stated it was her belief that Mayor Woerther violated the City's Code of Conduct at the City Council Meeting on January 11, 2016 and has concerns with some of the newly appointed Pond-Grover Loop Committee Members' ability to be objective. She stated she does not believe the City Council is acting in a consistent manner.

Gary Schroeder, 16642 Evergreen Forest Drive, stated he had submitted an application to be on the Pond-Grover Loop Road Committee but was not chosen. However, he would like to stay involved and contribute to the committees' review process.

Betsy Vanderheyden, 16560 Birch Forest Drive, stated her concerns with the appointed members to the Pond-Grover Loop Road Committee and echoed the statements made by Tammy Shea.

CITY ADMINISTRATOR DISCUSSION ITEMS

Contract for Custodial Services (Ward – Eight)

City Administrator Thomas noted that Resolution #2016-04 has been placed on the January 25, 2016 City Council Agenda for authorization of a new contract for custodial services at City Hall (including the Police Precinct) and Old Pond School. He stated

the Department of Administration is recommending a new contract with Accord Building Services for City custodial services, for an initial three (3) year term.

Discussion was held among City Council Members regarding the following items: how long the City has used the current custodial services; if the references provided by Accord Building Services were checked; and if the cleaning of the steps in City Hall could be improved.

Contract for City Hall HVAC Services (Ward – Eight)

City Administrator Thomas noted that Resolution #2016-05 has been placed on the January 25, 2016 City Council Agenda for authorization of a new contract for HVAC preventative maintenance services at City Hall (including the Police Precinct). He stated the Department of Administration is recommending a new contract with Murphy Company for City Hall HVAC Preventative Maintenance Services, for an initial one (1) year term.

Contract for Legislative Services – 2016 Legislative Session (Wards – All)

City Administrator Thomas noted Resolution #2016-03 has been prepared for the January 25, 2016 City Council Meeting, which would authorize a joint agreement with the firm, R. J. Scherr & Associates, for lobbying services related to legislation which may impact the St. Louis County Sales Tax distribution under consideration during the current Missouri Legislative Session. He added numerous municipalities have expressed interest in being a party to this agreement, which totals \$40,000 for the current legislative session, with the cost distributed between municipalities on a per capita basis. Thus, depending on the ultimate number of municipal partners, the total cost to the City of Wildwood is estimated to be in the range of \$7,000 - \$10,000.

COMMITTEE ACTION ITEM(S)/RECOMMENDATION(S)

Update on Rural Internet Access Project (Wards - All)

Director of Planning and Parks Vujnich noted a memorandum had been provided for the City Council's review and that he was available to answer any questions they may have regarding the Rural Internet Access Project. Director Vujnich also noted the three (3) new poles in the south half of the City went active on Friday, January 15, 2016, with the completion of the electrical connection to the facility on Allenton Road. The Department has also contacted Wisper ISP about the next steps in restarting efforts in the north half of the City, including the option of fiber optic service to the Wild Horse Creek Road Area. Given the efforts of Bays ET in the south half of the City, the Department is seeking to gain momentum within the north half of the City as well, since there are a number of residences not served at this time as well.

Status of the Master Plan Update Process – Public Input Session on January 20, 2016 (Wards – All)

Director of Planning and Parks Vujnich provided an update the Master Plan Advisory Committee (MPAC) and the public input session it held on the Preliminary Draft of the 2016 Version of the Master Plan. He noted the meeting was held at the St. Louis Community College – Wildwood Campus and approximately thirty (30) participants were in attendance with the comments from the two (2) small groups provided at the end of the update letter provided. He concluded that he was available to answer any questions they may have regarding the Master Plan Advisory Committee (MPAC).

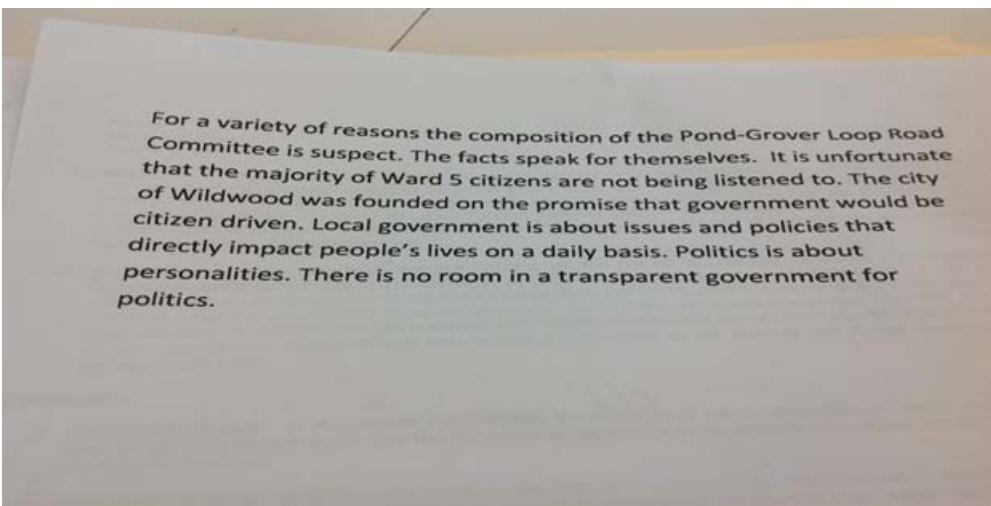
