CERTIFICATION OF APRIL 5, 2016 MUNICIPAL ELECTION

WHEREAS, on Tuesday, April 5, 2016, as required by law, and under the control and direction of the Board of Election Commissioners of St. Louis County, a municipal election was duly conducted and concluded within the City of Wildwood; and,

WHEREAS, the results of that election, as certified by said Election Board, have been forwarded to the City Clerk of Wildwood, and said results have been canvassed by the Council; and,

WHEREAS, Proposition B allowing the City to continue applying and collecting the local sales tax on the titling of motor vehicles, trailers, boats, and outboard motors that were purchased from a source other than a licensed Missouri dealer passed; and,

Section One

Section Two

With the passing of Proposition B, the City is authorized to continue applying and collecting the local sales tax on the titling of motor vehicles, trailers, boats, and outboard motors that were purchased from a source other than a licensed Missouri dealer.

Immediately upon executing the written Oath of Office, as required by law, the aforesaid duly elected and qualified Mayor and Council Members shall assume the full duties and responsibilities of their office, all in accordance with the provisions of the Charter of the City, and all applicable laws of this State and the Ordinances of the City of Wildwood and the Constitution and Laws of Missouri and the United States of America.

This Resolution shall be effective and in full force upon its passage and approval.
